McKinzie and Lot No 1 of the Heunon Tract and being a portion of  
the Heunon Land deeded to me by W.M. Thomas C.E.G.D. beginning at  
a Rock corner thence running South to Pine Stamp, thence North  
64/8 to a Red oak corner thence to the beginning corner containing  
Six and one half acres more or less. Together with all and singular  
the rights members hereditaments and appurtenances to  
the said premises belonging or in anywise incident or appertaining  
To have and to hold all and singular the premises before mentioned unto  
the said James Jenkerson his heirs and assigns forever, and I do hereby  
bind my self my heirs executors and administrators to warrant and
