Know all men by these presents that I A C Wilson of Dist & State aforesaid have bargained sold and mortgaged unto America Fowler & Blake Carlton for the sum of five hundred dollars to me in hand paid, all that piece parcel or tract of land that I purchased of S J Dill being situate & lying in the Dist & State aforesaid bounded by lands of Tho Chandler & Collins Sandy Goodlett & others containing seventy five acres more or less. To have and to hold from me my heirs or assigns forever, and bind myself my heirs or assigns to warrant and defend unto said Fowler & Carlton their heirs or assigns all the above named tract or parcel of land and appurtenances appertaining thereto unto forever. The condition of the above deed or mortgage is such that if I A C Wilson pay or causes to be paid unto S J Dill or order the sum of five hundred dollars for the payment of which America Fowler & Blake Carlton are my sureties, and for the payment of which said Dill holds our notes payable at different times, then the above deed or mortgage to be null and void and of no effect otherwise remain in full force and virtue.
