Dollars to me paid by Wm B Creaseman of Greenville District  
in the State aforesaid have granted bargained sold and released  
and by these presents do grant bargain sell and release unto the  
Said Wm B Creaseman all that certain piece parcel and tract of  
land lying and being in Greenville District and State aforesaid on  
waters of Laurel Creek waters of Needy River adjoining lands of Stokes  
Forrester Heauby and Mrs Paul, beginning at a rock 34 thence  
S 89 1/2 W 13.80 chs to a Rock thence S 67 1/2 W 17 chs to black Jack thence  
S 21 1/4 W 4.40 chs to a Rock thence S 48 3/4 E 46.50 chs to a Stake thence  
S 6 1/2 W 28.75 to the beginning containing forty seven acres and a half  
more or less, Together with all and singular the rights premises  
hereditaments and appurtenances to the said premises belonging or in any  
wise incident or appertaining, To have and to hold all and singular  
the premises before mentioned unto the said Wm B Creaseman his heirs  
and assigns forever And I do hereby bind my self my heirs executors and  
administrators to warrant and forever defend all and singular the said  
premises unto the said Wm B Creaseman his heirs and assigns me and  
my heirs and every other person whosoever lawfully claiming or to claim  
the same or any part thereof. Witness my hand and seal this twenty  
second day of November in the year of our Lord one thousand eight hundred  
and sixty four and in the 4<sup>th</sup> year of the Independence of the State
