sell and release unto the said Charles P Dean all that plantation
or tract of land containing Two Hundred and Twenty three acres
be the same more or less lying situated and being in the District
of Greenville and State of South Carolina aforesaid being part
of a tract of Land Originally granted to James Blasingame Recorded
in the Secretary of State's office in grant Book W. W. W. on page four
Hundred bounded by lines running N. W. to W & to E by Joshua Thompson
and N. E. by Mary Keall now Lands of Aaron Thompson Jesse Dean and
others, and hath such shape form and marks as are represented
by a plat of resurvey executed by Daniel Welbanks deputy Surveyor
on the fourteenth day of February Anno Domini 1806, Together with
all and singular the rights members hereditaments and appurtenances
