that I Richard Ross of the District and State aforesaid for and in consideration of the sum of twenty five hundred Dollars to me in hand paid by Thomas Steen of the same District and State have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Thomas Steen all that tract or plantation of land situated in the District and State aforesaid on Enoree River containing three Hundred and one acres more or less it being a part of a tract of land originally granted to Michael Johnson William and George Ross Sr beginning on a W O. Stake 3+ on Augusta Road thence N 39 1/2 E 42.36 to a small beach on the bank of the river thence up the meanders of the River to when Hammett Spring branch formerly emptied into the River branch now detached and turned below thence up the meanders of said branch to a Stake near a white oak pointer thence S 45 1/4 W 24.14 to a Stake 3+ Hammett and the oblique corner thence S 50 W 18.86 to a P. O 3+ n thence S 33 E 20.00 to a Stake 3+ n thence N 44 E 8.00 to a Stake by Augusta Road thence down said road S 28 1/2 E 16.20 to a Stake by road thence down same road S 35 1/2 E 24.12 to the beginning corner.
