I know all men by these presents that I  
John W Grady of Greenville District in  
the State of South Carolina do hereby convey to the said James Hedges & Brothers  
Four thousand two hundred and forty one dollars and seventy  
one cents to me paid by James Hedges William H Hedges Robert  
Hedges and William P Lewis Partners doing business under the name  
and style of Hedges Brothers of the city of Baltimore in the State of Maryland  
have granted bargained sold and released and by these presents  
do grant bargain sell and release unto the said James Hedges William  
H Hedges Robert Hedges and William P Lewis Partners doing business  
under the name and style of Hedges Brothers all that Lot and parcel  
of land situate lying and being in the town of Greenville and State  
aforesaid on Main Street & the South East corner of the Public Square  
beginning at a Stake original corner on the South East corner of Public  
Square & Main Street and running thence South  $17\frac{1}{2}$  West  $27\frac{1}{2}$  twenty seven & a half  
feet to a Stake corner of B F Perry's lot on Main Street thence  $17\frac{1}{2}$  East  $11\frac{1}{2}$   
feet along B F Perry's line to Stake corner at a fence thence  $17\frac{1}{2}$  West  $50\frac{1}{4}$  feet  
to a Stake on the dividing line between B F Perry's lot thence  $17\frac{1}{2}$  East  
 $23\frac{1}{2}$  feet to Stake on Spring Street thence along Spring Street  $17\frac{1}{2}$  East  $11\frac{1}{2}$  feet  
to a Stake corner of Spring Street & Court Street thence  $17\frac{1}{2}$  West  $500$  feet along  
the South side of Court Street to a Stake corner Public Square on Court Street  
thence  $17\frac{1}{2}$  West  $53\frac{1}{4}$  feet to a Stake original angle of Public Square thence  $72\frac{1}{2}$  West  
 $57\frac{1}{2}$  feet to the beginning corner being the same lot formerly occupied by  
G F Lawrence conveyed by said Lawrence to me and including all the entire  
portion & balance of the Square or lots embraced in the same lying South of  
Court Street and East of Main Street which has not heretofore been conveyed  
to B F Perry by the previous owners of said Square and bounded on the  
South by said B F Perry's lot on the East by Spring Street on the North  
by Court Street and on the West by Public Square and Main Street on  
which my Store houses and dwelling houses are situated together  
with all and singular the rights, members, hereditaments and appurtenan-  
ces to the said premises belonging or in any way incident or appur-  
tenant thereto and to hold all and singular the premises before mentioned  
unto the said James Hedges William H Hedges Robert Hedges and William  
P Lewis & their heirs and assigns forever. And I do hereby bind myself  
my heirs executors and administrators to warrant and forever  
defend all and singular the said premises unto the said James  
Hedges William H Hedges Robert Hedges and William P Lewis  
their heirs and assigns against me and my heirs and every other  
person whosoever lawfully claiming or to claim the same or any
