in the State aforesaid have granted bargained sold and
released and by these presents do grant bargain sell and
release unto the said Samuel Stradly all that head &
parcels of Land lying and being in the Corporate limit
of the town of Greenville South Carolina lying between
Anderson and Vardry Streets unfenced and not now cov-
ered in the enclosed lot of Ruth Lewis beginning at a
Stake 34 rod lot owned by Ruth Lewis and running thence
with her line 4 18 4 1/4 W 270 feet to a Stake 34 rod on the Parade
line road hence with Anderson Street 147 1/4 W 53 feet to a
Stake 34 thence S 31 1/2 W 20 feet to a Stake 34 thence with Vardry
Street 173 6 to the beginning corner containing two
Rodds and fifteen poles more or less. Together with all
and singular the Rights Member Instruments
and Appurtenances to the said premises belonging
or in any wise incident or appertaining. To have
and to hold all and singular the premises before
mentioned unto the said Samuel Stradly his heirs
and assigns forever. And I do hereby bind myself
my Heirs Executors and Administrators to warrant
and forever defend all and singular the said prem-
ises unto the said Samuel Stradly his heirs and
assigns against me and my Heirs and every other
person whomsoever lawfully claiming onto claims

released and by these presents do grant bargain sell and
release unto the said Samuel Stradly a certain
lot and parcel of land lying and being within the
incorporations of the Town of Greenville and State
and County aforesaid. Beginning at a Stake on
Pendleton Street and running with said street
169 1/4 W 99 feet and 4 inches to a Stake corner of Ruth
Lewis lot thence with said lot S 17 E 331 feet and running
to a Stake 34 rod distance from corner of Ruth Lewis street
S 17 E 130 feet to a stake thence N 84 1/4 W 452 feet to the
beginning. Two Rodds and twenty poles more or less
Together with all and singular the Rights Member
Instruments and Appurtenances to the said premises
belonging or in any wise incident or appertaining to
have and to hold all and singular the premises before
mentioned unto the said Samuel Stradly his heirs
and assigns forever. And I do hereby bind myself
my Heirs Executors and Administrators to warrant
and forever defend all and singular the said premises
unto the said Samuel Stradly his heirs and assigns ag-
ainst me and my heirs and every other person whomsoever
