which said Cabin is situated containing about one acre more or less
known as the Cabin wherein said Stairby now resides
Given under my hand & seals the 24th Oct A.D. 1857

come Whereas Frances Moor of the County
of Greenwell and State of South Carolina
late the widow and relict of Henry L Gross deceased late of the
County and State aforesaid who died intestate leaving a widow and
children heirs at Law and who was seized and possessed of a certain
tract of land lying and being in the County and State aforesaid
And whereas the said Frances Moor has lately in conformity
with the Statute of Distribution of the State of South Carolina
to and undivided their part of the said tract of land
and is desirous to sell and convey her said interest
aforesaid in the said tract of land as aforesaid
Now know ye that the said Frances Moor and
Jeremiah Moor her husband for and in consid-
eration of the sum of five hundred Dollars to
them paid at and before the sealing and delivery
of these presents by the following parties to wit John
P Shockey William H Groff John G Groff and Thomas
as of John Guardian of Phillip G Groff all of the
County and State aforesaid the receipt whereof
is hereby acknowledged hath granted bargain
sold and released remised and forever quit-
claimed and by these presents doth grant bargain
sell and released remised and forever quit-claim
unto the said parties aforesaid to wit John P Shockey
William H Groff John G Groff Thomas as of John Guardian for
Phillip G Groff and to their heirs and assigns forever

all the Dower and third right and title of Dower and third
and all other right and title interest property claim and demand
whatsoever in Law and in Equity of her the said Frances Moor
and Jeremiah Moor her heirs behd of in and to all that certain
piece or parcel of land before mentioned and lying and being in
the County and State aforesaid on the waters of South Upper
River some fourteen miles North from the Court House of Greenwell
County and joining lands of the late J D Ordeal deceased of R
Jackson and William Mc Maken it being a portion of what is
known as the Bush tract of land and containing one hundred
and fifty acres be the same more or less so that they the said
Frances Moor and Jeremiah Moor their heirs executors and
administrators or assigns nor any other person or persons for them or
either of them shall not have claim challenge or demand or pretend to
have claim challenge or demand any dower or third or any other right
title claim or demand whatsoever of in and to the same or any part or
parcel thereof in whatsoever hands be in or possession the same may
or can be and thereof and therefrom shall be ~~with~~ barred for-
ever by these presents together with all and singular the
rights Members hereditaments and appurtenances to the said
premises belonging or in anywise incident or appertaining
to have and to hold all and singular the premises before mentioned
unto the said John P Shockey William H Groff John G Groff and
Thomas as of John Guardian of Phillip G Groff and to their heirs and
assigns forever and we do hereby bind ourselves our heirs Execu-
tors and administrators to warrant and forever defend all
and singular the said premises unto the said parties aforesaid
their heirs and assigns against ourselves and against our
heirs and all other persons whomsoever lawfully claiming the
same or any part thereof All witness our hands and seals
the thirteenth day of August in the year of our Lord
one thousand eight hundred and sixty eight and in the
Ninety third year of the sovereignty and Independence of the
United States of America
