Dowdell Probate Judge as aforesaid in the Penal sum of
Sixteen hundred & thirty Dollars by a certain Bond bearing
date the first day of February Eighteen hundred and sixty
nine Dollars by a certain Bond bearing date the first day
February Eighteen hundred and sixty nine. Conditioned
for the payment of the full and just sum of Eight hundred
and thirty five Dollars Twelve months after date
with interest from the first day of February Eighteen
hundred and sixty nine. And this Indenture Witnesseth
That the said Daniel W. Holland for and in con-
-sideration of the sum of Two Dollars to the said
Daniel W. Holland by the said S. J. Dowdell Probate
Judge as aforesaid in hand paid at and before the
-sealing and delivery of these Presents has granted
bargained sold and released and by these Presents do
-grant bargain sell and release unto the said S. J.
Dowdell Probate Judge as aforesaid his successors in
-office or assigns All that Tract of Land Situate in
-Greenville County or waters of Adlers Creek bound-
-ed by lands of Josiah Bramlett and others and
-containing sixty five acres more or less being the same
-tract of land purchased by and this day from the Probate
-Judge as the property of Benjamin G. Gorman deceased
-for the sum of Eight hundred and thirty five Dollars
-payable Twelve months after date with interest four
-teen hundred and sixty nine. And this Indenture
-witnesseth that the said Daniel W. Holland and his
-singular the Right Heirs Heirs Executors and Appo-
-intees to the said Daniel W. Holland and his heirs
-and assigns do hereby covenant and agree to hold and

and singular the Premises before mentioned unto the said
Daniel W. Holland his heirs and assigns forever And I do hereby bind my Heirs
Executors and Administrators to warrant defend
defend all and singular the said Premises unto the said
S. J. Dowdell Probate Judge his successors in office his Heirs
and assigns against me and my Heirs and against
every person whomsoever lawfully claiming or to claim
the same or any part thereof Provided always nevertheless
and it is the true intent and meaning of the parties to
these Presents that if the said Daniel W. Holland his Heirs
Executors or Administrators shall will and truly pay or
-cause to be paid unto the said S. J. Dowdell Probate Judge
his successors in office or assigns the sum of Eight hun-
-dred and thirty five Dollars according to the conditions
of the Bond above mentioned then and from thenceforth
these Presents shall be utterly null and void any thing
-herein contained to the contrary thereof in anywise
-notwithstanding and it is covenanted and agreed upon
-by and between the parties to these Presents that until
-default shall be made in payment of the aforesaid sum
-as before set forth and the interest for the same it shall
-and may be lawful to and for the said Daniel W. Hol-
-land and his heirs and assigns to hold use occupy possess
-and enjoy all and singular the Premises above gran-
-ted and released and every part thereof with the
-Appurtenances and to have receive and take the
-rents issues and profits thereof to his own particular
-use and behoof any thing herein contained to the
-contrary hereof in anywise notwithstanding. In
