 I A B Vickers Sheriff of Greenville  
 County and State aforesaid send Greeting Whereas by virtue of a  
 writ of fieri facias issued out of the Court of Common Pleas  
 held for the County of Greenville dated the fourteenth day of May  
 in the year of our Lord One thousand eight hundred <sup>and</sup> sixty  
 nine at the suit of Wm D Dickey to me directed commanding  
 me that of the goods <sup>and</sup> chattels lands and tenements of Thomas  
 A Holzclaw to levy the sum of three hundred sixty one <sup>and</sup> 1/100

 or secured to be paid by the said John W Holzclaw the receipt  
 and payment whereof I do hereby acknowledge have granted bar-  
 gained and sold and by these presents do grant bargain <sup>and</sup> sell -  
 unto the said John W Holzclaw his heirs and assigns forever  
 the said tract piece <sup>and</sup> parcel of Land with its appurtenances <sup>and</sup>  
 all the estate right title and interest which the said Thomas A  
 Holzclaw of right had of in and to the same To have <sup>and</sup> to hold the  
 said piece parcel and tract of Land with its appurtenances unto the  
 said John W Holzclaw his heirs <sup>and</sup> assigns forever as fully <sup>and</sup>  
 absolutely as the said A B Vickers might could or ought to  
 grant bargain and sell the same by virtue of the statute aforesaid
