State of South Carolina Know all men by these presents that I Maries Priest of the City of Charleston in the said State in consideration of the sum of Two thousand and five hundred Dollars to me paid by Hornet Elizabeth Stradley the wife of Samuel Stradley of Greenville County in the said State have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Hornet Elizabeth Stradley; All those two pieces parcels or lots of Land, situate lying and being in the corporate limits of the Town of Greenville in the County of Greenville and State aforesaid, about one mile from Greenville Court House and having respectively the following metes lines and bounds to wit one lot upon the south side of Pendleton Street, beginning at a stake 3x upon Pendleton Street and running thence N 74 W with said street four hundred feet to a stake at Street thence S 16 W with street four hundred feet to stake at Street and thence N 16 E with Street four hundred feet to the
