





and State aforesaid have granted bargained sold and released
and by these presents do grant bargain sell and release unto
the said Mrs Rebecca G Jones All that certain piece parcel or
lot of Land situate lying and being in the County of Greenville
and State aforesaid within the corporate limits of the City of
Greenville on the South Side of Bumcombe Street about one acre
from the Court House adjoining lands of Messrs Burgess and
Gilbreath and lands of the Estate of W P M Bee deceased
containing Two Acres the same being more or less Beginning at
Stake 3x on the said Bumcombe Street Messrs Burgess and Gilbreath
(corner) and running thence with the said Street S 37 E 208 1/2 feet
to a Stake 3x, thence N 53 W 41 1/2 feet to a Stake 3x, thence N 37
E 208 1/2 feet to a Stake 3x Messrs Burgess and Gilbreath's corner
thence with the said Messrs Burgess and Gilbreath's line N 53 E
