R. containing five and 1/10 Acres be it the same more or less commencing at Stone corner n.w. thence S 83 1/2 E 7.70 ch. to Stone 7 o.m. thence N 6 1/2 E 8.68 ch. to Stone x, n.w. thence along the right of way of said Road thence S 11 E 3.22 ch. to the beginning corner bounded by lands of said right of way said Joseph Edwards and Edwards lands together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. To have and to hold all and singular the premises before mentioned unto the said Joseph Edwards his heirs and assigns forever.
