 Isaac M Bryan This Indenture made this 18<sup>th</sup> day of March A D 1875 between Thomas L Fowler and Thomas R Fowler heretofore partners in trade doing business in the City of Greenville in the county and State aforesaid under the style of Fowler and Son of the first part and I M Bryan assignee of the Estate and effects hereinafter referred to of the second part witnesseth that whereas the parties of the first part are indebted to divers persons in considerable sums of Money which he is at present unable to pay in full and they are desirous to convey all their property for the benefit of all their Creditors without any preference or priority now the parties of the first part in consideration of the premises and of one Dollar paid to them by the party of the second part truly sell assign grant and convey unto the party of the second part all their goods Chattels property and Choses in action of every name nature and description where so ever the same may be accept such property as is by law exempt from execution to have and to hold the same unto the said party of the second part in trust to sell and dispose of said personal Estate and to collect the said Choses in action with the right to compound for the said Choses in action taking part for the whole when the party of the second part may deem it expedient to do so then in trust to dispose of the proceeds of the said property in the manner he shall see fit to pay the debts and charges

of these presents and the expenses of executing the trust declared and set forth herein To distribute and pay the remainder of the said proceeds to all the Creditors of the said parties of the first part for all debts and liabilities which the said parties of the first part may be owing or indebted to any person whatever provided however that if there is not sufficient funds for the payment of all the debts of said parties of the first part then the said debts are to be paid pro rata or in proportion to their respective demands the rest residue and remainder if any there be after paying said Costs Charges expenses and debts as aforesaid the said party of the second part is to pay over to the said parties of the first part their Executors administrators or assigns In witness whereof the said parties of the first part hereunto set their hands this 18 day of March A D 1875
