Gower, be appointed Trustees to whom William A. MacDaniel Clerk of the said Court, should convey the said lands to have and to hold the same, to, for ever upon the purposes, uses and trusts, as set forth and recited in the above report by the said referee and whereas, the said William A. MacDaniel Clerk as aforesaid, did convey the lands mentioned in the pleadings to the said Trustees, and whereas the said Trustees were ordered to convey the lots heretofore sold upon the purchaser complying with terms of sale. Now therefore know all men by these presents that we Thomas L. Gower and Whitney Symmes Trustees as aforesaid by virtue of the power aforesaid is poss'd. in and by the order and trust aforesaid aforesaid, upon the written request of the Testis quoth trust herein endorsed, abiding performance of our duty as such Trustees and also in consideration of the sum of two Dollars and Eighty Dollars, to us paid by W. D. Perry before the delivery of these presents have granted, bargained, sold and released, also by these presents do grant, bargain, sell and release unto the said W. D. Perry all that piece parcel or lot

or building bounded off the lands

above mentioned, situate and lying in the City and County of Greenville and State of South Carolina commencing at a Stake on corner of Street running thence S. 4 $\frac{1}{2}$ E fifty feet to a Stake thence N. 3 $\frac{3}{4}$ E one hundred and twenty feet to a Stake, thence S. 4 $\frac{1}{2}$ E forty feet to a Stake, thence S. 8 $\frac{1}{2}$ E along said to the beginning corner being the same lot as is represented on Plat of Survey by Dickson Surveyor made day of September A.D. 1843 and known in said Plat as lot Number eight. Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. I have and to hold all and singular the premises before mentioned unto the said W. D. Perry his heirs and assigns forever freed from and discharged of all further trusts whatsoever, and we do hereby bind ourselves our heirs Executors and administrators to warrant, and forever defend all and singular the said premises unto the said W. D. Perry his heirs and assigns against us, and our heirs and every other person whomsoever lawfully claiming, or to claim the same or any part thereof, by through and under us as Trustees aforesaid.
