

Elizabeth Robertson of Greenville in the County of Greenville and State of South Carolina of the second part; whereas the County Auditor of each and every County in the State of South Carolina is authorized and required by an act of the General Assembly of the State, entitled "an act providing for the assessment and taxation of property passed September 15 1868 and all acts amendatory thereto" approved March 12, 1872 to execute a Warranty Deed to the purchaser or purchasers of all property forfeited to the State under the provisions of the said act providing for the assessment and taxation of property and said other acts amendatory thereto and sold by the County Treasurer under the provisions of said acts: - Now therefore this Indenture witnesseth that I M. Robertson County Auditor of the County of Greenville in the State aforesaid, of the first part in consideration of the sum of Three and 25/100 Dollars good and lawful money of the United States, to me in hand paid by the said Elizabeth Robertson of the second part; for and in behalf of the State of South Carolina have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Elizabeth Robertson all that certain Lot or tract or parcel of Land bounded and described as follows to wit: bounded by lands of John D. Hyde Thos Lang and others containing One and seven Eighths of An Acre more or less Together with all and singular the rights members hereditament and appurtenances to the said premises belonging or in any wise incident or appertaining: To have and to hold all and singular the premises before mentioned unto the said Elizabeth Robertson her heirs and assigns forever. And I M. Robertson County Auditor as aforesaid do hereby bind the State of South Carolina to warrant and forever defend all and singular the said premises unto the said Elizabeth Robertson her heirs and assigns against the said State of South Carolina and against every person and all persons whomsoever

Lawfully claiming or to claim the same, or any part thereof. Lock, Mrs. Elizabeth Cook and Wilson conveyed to me and decided by W. W. McDaniel, Clerk of the Court of Greenville County So. Ca. by an order did convey by deed and execute title to Mrs. A. P. Lock to her and her heirs and assigns Beginning at a corner on Georgia Road Thence run S 41 E 19 3/4 to Stake 37 on corner line Thence S 87
