that William Goldsmith of Greenville County in the State aforesaid in consideration of the sum of One Thousand Dollars to me in hand paid at and before the sealing of these presents by Mr N G Goldsmith of Greenville County in the State aforesaid (the receipt whereof is hereby acknowledged) I have granted bargained sold and released, and by these presents do grant bargain sell and release unto the said Mr N G Goldsmith all that piece parcel and tract of land situate lying and being in Greenville County South Carolina containing five hundred and forty five acres or less and having the following lines metes and bounds to wit Beginning at a stone 3x0 on the Limerick Road and running thence N 25 E 045.68 chains to a stone 3x0 m thence S 66 2/3 W 29.45 chains to a stone 3x0 m in the Limerick road thence N 57 1/4 W 45.0 chains to an oak 3x0 m thence S 62 W 35.10 chains to a stone 3x0 m thence S 12 1/2 E 99.50 chains to a stone 3x0 m thence S 33 E 3.19 chains to a Poplar 3x0 m on the bank of the branch below the lower mill, thence S 80 E 2.62 chains to a rock 3x0 m thence N 26 E 44.50 chains to a rock 10.9x0 m thence N 17 1/2 E 25.50 chains to a stone 3x0 m thence S 52 E 36 chains to a stone 3x0 m thence S 34 1/2 E 30.75 chains to a stone 3x0 m thence S 29 E 1.74 chains to a stone 3x0 m thence S 67 W 33.50 chains to a stone 3x0 m thence N 51 W 21.66 chains to a stone 3x0 m thence N 34 1/2 E 27.34 to a stone 3x0 m on the Limerick Road thence N 93 1/2 W up said Road 16.60 chains to a stone 3x0 m thence up said Road N 34 1/2 W 10.60 chains to the beginning.
