 rate use and of the said Josephine B. Norwood, for and during
 the term of her natural life; and after her death to her
 heirs, and upon the further trust and condition that should
 the said Josephine B. Norwood or her heirs or one or more of them
 after her death, upudiate, or set aside the conveyance of the
 land in Alabama conveyed to me by said Nathan L. Lipscomb
 trustee as aforesaid, by virtue of the authority of a decretal order
 of his Honor Judge Thompson McLoore Circuit Judge for said state
 of South Carolina, dated 27th day of December 1875 and by a deed
 made to me, by said Lipscomb in pursuance of the authority
 of said order, on the 13th day of March A.D. 1877 a full description
 of which land is contained in the said last mentioned deed and
 was conveyed to me in consideration of the execution of this
 deed, and one thousand dollars besides then and in such case the
 said Nathan L. Lipscomb shall hold the premises hereby conveyed
 or such part thereof as will be sufficient to indemnify the said
 Mary R. Norwood for any loss or damage taken title to the said
 land in Alabama in trust for the sole use and benefit of the
 said Mary R. Norwood and shall upon request recover the same
 to her. And I do hereby bind myself my heirs executors and
 administrators to warrant and forever defend all and singular
 the said premises unto the said Nathan L. Lipscomb and his
 successors against myself and my heirs and all persons lawfully
 claiming or to claim the same, or any part thereof.
