Hodges of Greenville County in the State aforesaid for and in consideration of the sum of Four hundred and Ninety Dollars to me in hand paid at and before the sealing of these presents, by William P Heart of Greenville County in the State aforesaid, (the receipt whereof is hereby acknow- ledged) have granted bargained sold and released, and by these presents do grant bargain sell and release unto the said William P Heart a tract of land lying and being situate in Greenville County and State aforesaid on some small branches waters of South Tyger River (being part of my home tract and vines as follows: i. beginning at a stone 3x thence S 53 E 33 chains to a stake 3x thence N 45 E 17 75 chains to Red Oak 3x (900) thence S 84 E 34 00 chains to Pine 3x thence N 37 E 11 50 chains to a Dogwood 3x thence N 8 W 28 00 chains to a stake 3x thence N 48 1/2 W 22 25 chains to a chestnut 3x thence N 78 W 35 00 chains to a Pine 3x thence S 37 W 35 90 chains to a Red Oak 3x thence N 6 3/4 W 11 20 chains to a chestnut 3x thence S 71 W 6 58 chains to a chestnut Oak 3x on top of mountain thence S 41 1/4 W 7 42 chains to a stone 3x thence S 34 W 39 85 chains to the beginning stone 3x containing three hundred acres but the same more or less bounded by lands of Wm Trautman, Presha Stinner, Healey, Elisha Pruett and myself Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
