Southern of Greenville County in the State aforesaid (the receipt whereof is hereby acknowledged) have granted bargained sold and released and by these presents do grant bargain sell and release unto the said W. D. Southern a certain tract piece or parcel of land lying and being situate in Greenville County in the State aforesaid on a branch of Marsh Creek waters of South Syger River and is part of a tract of land conveyed to me by Geo. H. Gordon by Deed dated January the 11th 18th 75 as part of the Nicolls grant and runs as follows i.e. beginning on a dead Sassafras 37th E 15.92 chains to Poplar 37th Corner of Nicolls Grant) thence S. 34.14 E 18.50 chains to a stake 37th in an old Road thence along said old Road 5.00 chains to a stone 37th on side of said road thence N. 75.2 3/4 W 15.50 chains to a stone 37th by a corner road thence N. 75 3/4 W 13.68 chains to a stone 37th thence N. 8 E 3.40 chains to a Poplar 37th (down) thence N. 24 E 8.10 chains to the beginning corner containing twenty nine and one fourth (29 1/4) acres more or less bounded by lands of W.
