that I, Alabrook L. Cobb of  
Greenville County, in the state aforesaid, in consideration of  
One Thousand Dollars (\$1000.00) to me paid by Robert M.  
Wallace of Charleston County, in the state aforesaid, have  
granted, bargained sold and released and by these presents do  
grant, bargain sell and release unto the said R. M. Wallace  
all that lot or parcel of land in the corporate limits of the  
City of Greenville on the west side of the Augusta Road - Beg-  
inning at a stake corner on the south side of a street on  
said road thence along said street 689 1/4 W 9, 40. chs to stake  
corner at alley thence along said Alley 614 W 9, 27 chs to stake  
thence N 89 1/4 E 11, 16 chs to stake on said road, thence N 18  
W 1, 38 chs to angle thence N 13 1/4 E 1, 90 ch to the beginning  
corner containing three + 1/4 acres more or less and bounded  
by said Augusta road, said Street and Alley and likewise  
said Henry P. Hammatt. Together with all and singular  
the rights, members, hereditaments and appurtenances to the  
said premises belonging, or in any wise incident or appertain-  
ing, > To have and to hold all and singular the premises  
before mentioned, unto the said R. M. Wallace his heirs  
and assigns forever, and I do hereby bind my heirs exec-  
utors and administrators, to warrant and forever defend  
all and singular the said premises, unto the said R. M.

or to claim the same, or any part thereof.
