The State of South Carolina  
Know all men by these presents  
that I Hetty Smith in the State  
aforesaid and in consideration

of the sum of Two Hundred (270) and seventy Dollars to me in  
hand paid at and before the sealing of these presents by  
Emelia E Mason in the State aforesaid (the receipt whereof is hereby acknowledged) have granted bargain  
and release and by these presents do grant bargain  
sell and release unto the said Emelia E Mason all that plant-  
ation or tract of land lying South of Spartanburg Road and  
West of Currier River and on waters of Currier River, in  
the County aforesaid, lying in manner and form as follows  
Beginning at Rock 3x in grave yard on Pinkey Vaughan's  
line thence S 69° W twenty four chains and twenty five links  
to Stake 3x on P Vaughan line thence S 45° W eight chains  
and fifty links to Stake 3x on E G Smith's line thence  
N 41° W twelve chains to Stake 3x on branch on I G Smith's  
line thence down branch eight chains to Sweet Gum 3x on  
branch thence S 65° E seven chains to Red Oak 3x on Spartanburg  
Road thence down Spartanburg road twenty six chains and  
sixty links to rock 3x on road thence S 24° E eighteen chains  
to beginning, the same containing forty four (44 1/2) and a half  
acres more or less being originally granted part to John Ross  
part to Peter Brooks Together with all and singular the  
rights members hereditaments and appurtenances to the said premises  
belonging or in anywise incident or appertaining To have and to  
hold all and singular the said premises before mentioned unto  
the said Emelia E Mason her heirs and assigns forever  
And I do hereby bind myself my heirs executors and administra-  
tors, to warrant and forever defend all and singular the said  
premises unto the said Emelia E Mason her heirs and assign-  
ees against myself and my heirs and every person whomsoever  
lawfully claiming, or to claim the same or any part thereof.
