This indenture, made the third day of June in the year of our Lord one thousand eight hundred and seventy eight between William A M^c Daniel Esq^r, Clerk of the Honorable Circuit Court for Greenville County, at Greenville Court House in the said State: of the one part, and Lillie L Reilly of the other part; Whereas Lillie L Reilly formerly Lillie L Goldsmith on or about the 26th day of December in the year of our Lord one thousand eight hundred and seventy six exhibit her complaint in the Circuit Court, at Greenville Court House in the said State, against W B Arnold and A J Braullett for the foreclosure of a mortgage And the cause, being at issue before the Honorable Court, came on to be heard at March term, in the year of our Lord one thousand eight hundred and seventy eight when the said Court, after full hearing thereof, and mature deliberation in the premises, did order, adjudge and decree, that the tract of land described in the Complaint should be sold at public auction, by the Clerk of the said Court, on the terms and for the purposes mentioned in their decretal order, as by reference thereto in the Registry of the said Court, will appear; and the said William A M^c Daniel Esq^r, as Clerk of the said Court, after having duly advertised the said tract of land for sale, by public outcry, on the third day of June in the year of our Lord one thousand eight hundred and seventy eight did then, openly and publicly, and according to the custom of auctions, sell and dispose of the said tract of land below described, unto the said Lillie L Reilly for two hundred and fifty Dollars she being, at that price, the highest bidder for the same. Now therefore this indenture witnesseth that the said William A M^c Daniel Esq^r, as Clerk of the said Court, under and by virtue of the said decree, and in consideration of the sum of two hundred and fifty Dollars paid him by the said Lillie L Reilly the receipt whereof is hereby acknowledged, hath granted bargain sold and released and by these presents doth grant bargain sell and release unto the said Lillie L Reilly her heirs and assigns, all that tract of land situated in Greenville County, State of South Carolina, waters of Horsepen Creek beginning at a Chestnut stump 3 x thence S 34 W 43.50 chains to a stone 3 x thence N 24 W 60 chains to a stone 3 x thence S 72 1/2 E 52 chains to a Post Oak 3 x thence S 5.50 chains to the beginning corner containing one hundred and twenty four acres more or less together with all and singular the hereditaments rights members and appurtenances whatsoever, to the said tract of land belonging, or in anywise appertaining; and the reversions and remainders rents issues and profits thereof; and also all the estate right title interest power possession property benefit claim and demand whatsoever, both at law and in Equity of the heirs and representatives of the said W B Arnold and A J Braullett and of the parties to this suit, and of all other persons rightfully claiming, or to claim the same on any part thereof, by, from, or under them, or either of them

To have and to hold the said tract of land, with its hereditaments, privileges and appurtenances, unto the said Lillie L Reilly her heirs and assigns, to them and her only proper use, benefit, and behoof forever.

To have and to hold all and singular the premises before mentioned unto the said M A C Moore her heirs and assigns forever. And I do hereby bind myself my heirs executors and administrators, to warrant and forever defend all and singular the said premises unto the said M A C Moore her heirs and assigns, against me and my heirs or any other person lawfully claiming, or to claim the same or any part thereof
