King in the State aforesaid, the receipt whereof is hereby acknowl-
edged have granted bargained sold and released, and by these
presents do grant bargain sell and release unto the said H O
King all that certain piece parcel and tract of land situate
lying and being in the County and State aforesaid on the White
House Road, bounded by lands of Ann Thompson Paul Stone
the Greenville and Columbia Rail Road and by the White
House Road being a portion of the tract of land purchased

by me from Smith L Davis and containing forty seven and one
half acres more or less Together with all and singular the rights
members hereditaments and appurtenances to the said premises belonging
or in anywise incident or appertaining. To have and to hold all and
singular the said premises before mentioned unto the said H O
King his heirs and assigns forever. And I do hereby bind myself
my heirs executors and administrators, to warrant and forever def-
end all and singular the said premises unto the said H O King
his heirs and assigns, against one and my heirs and every other person
lawfully claiming or to claim the same or any part thereof.
