County, in the State aforesaid in consideration of two hundred Dollars to me paid by John Howell of Spartanburg County in the State aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said John Howell all that tract or parcel of land situate lying and being in the State and County aforesaid on waters of Beaver Dam Creek: Beginning on a large poplar on a branch and measuring thence N 6 E 20 chains to a stone: thence N 8 1/2 E 16.50 chains to a Red Oak thence N 6 E 15.20 chains to a stone on Mag by's line thence along said line S 8 1/2 E 8.21 chains to Post in place of pine gone: thence S 2 1/4 W 46.20 chains to a stone on a branch: thence down the meanderings of said branch to the beginning corner containing fifty acres be the same more or less. Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. To have and to hold all and singular the premises before mentioned unto the said John Howell his heirs and assigns forever. And I do hereby bind myself my heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said John Howell his heirs and assigns against me and my heirs and every other person whomsoever lawfully claiming or to claim the same or any part thereof.
