to Hickory 3x dead, thence N 67 $\frac{1}{4}$ E 18.70 to a Pine 3x down, thence S 85 $\frac{1}{2}$
E 10.80 to a Spanish Oak down thence S 81 $\frac{1}{4}$ E 6.55 to a stone 3x R Oak
gone, thence S 88 $\frac{1}{2}$ E 6.90 to a stone 3x + Pine Rush, thence N 2 $\frac{1}{2}$ W
