Earle on the West, by the land recently sold to David Long & on the South by lands sold to George Croft & on the East by the said P Brumau, as by reference to the said plat will more fully & at large appear Together with all and singular the rights appurtenances thereto belonging or in anywise incident thereto to hold the same & every part thereof to him his heirs & assigns forever, and I the said Edward Croft do hereby herein bind myself & my heirs executors & assigns forever to defend & warrant the same to the said David Keuning his heirs & assigns & every part thereof both from myself & also from every person or persons claiming or lawfully claiming the same
