Douthick Master as aforesaid in consideration of the premises, and also in consideration of the sum of five hundred and fifteen Dollars paid me by the said Lawrence Leubardt the receipt whereof is hereby acknowledged, have granted bargained sold and released, and by these presents do grant bargain sell and release into the said Lawrence Leubardt and his heirs and assigns, all that tract of land situate lying and being in the County of Greenville and State aforesaid, Beginning at a stake 87 x n.w. thence N 77 1/2 W 20.00 to a stone 87 x n.w. thence S 23 1/2 W 22.00 to a stone 87 x 0 m thence S 66 1/4 E 2.00 to a small Poleum 3 x 0 m on creek thence down said creek 13.65 to a white O. 3 x one thence S 60 W 16.20 to a P. 05 x 3 x 0 m thence S 42 1/2 W 6.60 to a stone 3 x 3 x in the Road thence S 16 1/2 E 4.73 to a bend in the said Road, thence S 1 1/4 W 8.83 to a Red Oak 3 x 3 x n.w. thence N 77 1/2 E 18.50 to a stone 87 x n.w. thence S 78 E 15.50 to a stone 3 x 0 x 0 m thence N 9 1/2 E 50.22 to the beginning corner adjoining lands of John Butterfield and others, and containing One hundred and thirty five acres, more or less.
