situate lying and being in the City and County of Greenville
in the State aforesaid adjoining lands of Adam Walker
Charles J. Hammond and others and containing Fourteen
(14) Acres more or less being the land originally conveyed
to H. D. Gibson by A. Leath Together with all and
singular the rights members hereditaments and appur-
tenances to the said premises belonging or in anywise
incident or appertaining. To have and to hold all and
singular the said premises before mentioned unto the
said W. A. McDaniel his heirs and assigns forever and I
do hereby bind myself my heirs executors and administ-
rators to warrant and forever defend all and singular
the said premises unto the said W. A. McDaniel his
heirs and assigns against me and my heirs every
other person whatsoever lawfully claiming or to claim
the same or any part thereof.
