land N 45° E 16.60 chs to a Black Jack + Rock in place,
thence N 37° W 16 chs to a P. O + on whitins land N 47°
W 27.50 chs to a P. O + thence S 45° W 16 chs to Pine + the
beginning containing Seventy eight acres, to the
