Goodwin as trustee of the North Fork of Saluda Baptist Church in the County and State aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said Walter B. Goodwin Trustee as aforesaid all that piece parcel and tract of land containing three (3) acres more or less upon which the New meeting house of the said North Fork of Saluda Baptist Church is situated being on Waters of North of Saluda River and adjoining lands of Davis W. Hodges and Mrs S. A. Goodwin and having the following buttings and boundaries to wit beginning at a Rock corner or new marks on the North side of the Greenville Road running thence North 17 West 17 1/2 chains to a stake corner on Mrs S. A. Goodwin's line thence with said line ~~Down~~ Branch thence down said Branch to a Bridge on the Greenville Road thence with said road to the beginning rock corner together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining. To have and hold all and singular the premises aforesaid

his heirs and assigns forever in trust for the aforesaid North Fork Saluda Baptist Church to be held possessed and enjoyed by the said North Fork of Saluda Baptist Church forever as a place of religious worship and burying place and I do hereby bind myself my heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said Walter B. Goodwin in trust as aforesaid his heirs and assigns against myself and my heirs and against every other person whomsoever lawfully claiming or to claim the same or any part thereof.
