in the State aforesaid, (the receipt whereof is
hereby acknowledged) have granted bargained
sold and released, and by these presents do grant
bargain sell and release, unto the said Thomas J
Harrison his heirs and assigns a certain tract
piece or parcel of land situated in State and
County aforesaid on waters of South Pacolet
River and bounded as follows beginning near
Black Gum near its ford on the east east of
Mathew Bruce's fence up the creek till it strikes
Joshua Ludliff's line to a stake then nearly
North to a Locust thence nearly North West
to a double Chestnut thence nearly north
to James Ludliff's line to a stake thence
with James Ludliff's line to a Chestnut
near the Jefferson's Center old house thence
70 links to a stake thence nearly North
East to a Spanish Oak down (over) River
thence nearly South East to the beginning
Black Gum corner containing Ninety
(90) acres more or less Together with
all and singular the rights members
hereditaments and appurtenances to the
said premises belonging or in any way
incident or appertaining To have and

before mentioned unto the said Thomas J Harrison
his heirs and assigns forever And I do hereby
bind myself my heirs executors and administrators
to warrant and forever defend all and singular
the said premises unto the said Thomas J Harri-
son his heirs and assigns against myself and
