Lomas's lot, thence S 34 1/4 W 77 feet to corner of lot # 10 Johnson's survey, thence N 55 3/4 W 138 feet to 30 foot street, thence N 40 E 77 feet to the beginning corner, being known as lot # 14 of Johnson's survey of June 9th 1881.
