shall come: S. J. Donthit master in and for the County
aforesaid send greeting: Whereas Henry C Marsley
on or about the 8th day of September in the year of
our Lord eighteen hundred and eighty exhibited
his complaint in the Court of Common Pleas for
the County aforesaid, against Hannah J Cox, James
S. Laurean and others demanding judgment
in relation to the real Estate hereinafter mentioned
and described; and the cause being at issue
came on to be heard on the 14th day of July 1882
and such proceedings were had therein as resulted
in a decreed order of the said Court, whereby it
was adjudged and decreed that the said Real
estate hereinafter mentioned and described be
sold by S. J. Donthit master in and for the
County aforesaid under the terms and for the

order as by reference thereto on file in said Court will
appear; and the said master, after having duly advert-
ised the said Real Estate for sale by public outcry, on
the 6th day of November in the year of our Lord eighteen
hundred and eighty two did then openly and publicly,
and according to the custom of auction, sell and dis-
pose of the same unto Sallie M Gower for the sum
of Two hundred and forty one dollars, being not that
price the highest bidder therefor. Now therefore, know
all men by these presents, that S. J. Donthit master
in and for the County of Greenville aforesaid, in assid-
eration of the sum of Two hundred and forty one
dollars to me paid by the said Sallie M Gower the
receipt whereof is hereby acknowledged, have granted
bargained, sold and released, and by these presents
do grant bargain, sell and release unto the said
Sallie M Gower, all that lot or parcel of lands,
situate lying and being in the City and County of
Greenville and State aforesaid, Beginning at a stake
on the Anderson Road, thence S 11 1/2 W 223 feet to a
stake on a level 30 foot alley, thence S 70 3/4 E 337 1/2
feet with said alley to a stake on corner of lot of
Charles White, thence N 20 W 168 feet to a stake, thence
S 73 1/4 E 137 feet to a stake on a fifty foot street
thence with said street N 26 E 121 feet to a stake
on a thirty foot street, thence with said street
N 79 W 526 1/2 feet to the beginning corner contain-
ing two and forty six one hundredths acres
more or less Together with all and singular the
rights members hereditaments, and appurtenances
to the said premises belonging, or in anywise incident
or appertaining, and all the estate, right, title,
claim and interest whatsoever, of the parties to
the cause aforesaid, and of each of them, in and to
the same, and of all other persons rightfully claim-
ing from, under or by them or any of them,
