said road, thence $\text{A} \frac{2}{4} \text{ & } 13.30$ chas with said
road to another bend in road thence A with
said road to the ford of the creek to Mary Jane
Hill, corner, thence A up said creek to a
concluded corner, thence to a stone corner
of H. N. Salmon's & my own land, thence $\text{S} \frac{3}{4} \text{ & }$
 $\text{A} \frac{1}{4} \text{ & } 10$, chas to a stone on side of said ^{mill} road 159 chas
from Hickory, thence $\text{S} \frac{1}{4} \text{ & } 16.81$ chas to the
