Hill of the County of Greenville in the State aforesaid, in consideration of the sum of Eight hundred Dollars, to me paid by Sallie Ann Robertson of the County of Greenville, in the State aforesaid, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said Sallie Ann Robertson all that certain piece parcel or tract of land situated lying and being in the County of Greenville about twelve and a half miles from Greenville Court House on the Burncomb Road and running at crossing of Burncomb and Mill Road and running thence N 36 1/2 E 11.05 chas to a bend in said road, thence N 29 1/2 E 13.30 chas with said road to another bend in road: thence N with said road to the ford of the creek to Mary Jane Hill's land, thence N up said creek to a conditional corner thence to a Stone corner of H. A. Salmons & my own land, thence S 28 1/2 E 26.10 chas to a stone on side of said ^{mill} road 159 chas from Hickory, thence S 64 1/4 E 16.81 chas to the beginning corner containing Fifty acres more or less, Together with all and singular the Rights, Members, Hereditaments and appurtenances to the said premises belonging in anywise incident or appertaining: To have and to hold, all and singular the said premises before mentioned unto the said Sallie Ann Robertson, Heirs and Assigns forever. And I do hereby bind myself my Heirs Executors and Administrators, to warrant and forever defend all and singular the said premises unto the said Sallie Ann Robertson Heirs and Assigns, against me and my Heirs, or any other person or persons lawfully claiming, or to claim the same or any part thereof.
