That I, William H Goodwin of the County of Greenville in the State aforesaid, for and in consideration of the sum of Seven thousand two hundred and fifty dollars (\$7250.) to me paid by Robert G Williams of the County of Greenville in the State aforesaid, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell, and release unto the said Robert G Williams, all that certain piece or parcels of land situate lying and being in the City of Greenville in the County and State aforesaid, on the west side of Main Street and bearing the following lines and bounds to wit, Beginning at the center of the east end of the wall which divides the lot above described occupied by J. A. Goodwin from that occupied by Robert G. Davis on Main Street, and running from
