of the State of South Carolina, the receipt whereof is hereby
acknowledged, have granted, bargained, sold and released
and by these Presents do grant, bargain, sell and release
unto the said Isaac M. Bryan his heirs and assigns
forever, All that certain tract, or parcel of land situate,
lying and being in the State of South Carolina, County of
Greenville, City of Greenville, and bounded, as follows:
