I now give and convey said lands on the death of my said daughter to her Children surviving her or living at her death and share and share alike and should any Child of my said daughter die in the life time of my said daughter leaving a Child or Children living at the death of my said daughter such Child or Children shall take the share in said tracts of land which his or her deceased Parent would be entitled to if such deceased Parent had survived my said daughter I hereby reserve unto myself the use and enjoyment of the rents issues and Profits of said tracts of land and the absolute control and management of them during my natural life.

 Know all men by these presents that I, Mary H. Stokes of the County and State aforesaid for and in consideration of the love and affection I have for and bear to my daughter Henrietta E. Gaines and for and in consideration of the sum of five dollars to me paid by her have given granted released and conveyed and do hereby

time only and on the conditions herein after set forth the following tract and Parcel of land situate lying and being in the County and State aforesaid to wit that tract of land situate on the left hand side of the Public Road [leading from Jesse C. Hill goes from residence to Anderson Bridge on Conasa River on which the Homestead building & residence of my father Isaiah Hill goes is situated it being all that portion of the tract of land allotted to me in the division of the Homestead tract of land of my said father on said left hand side of said Road containing about one hundred and seventy five acres more or less bounded by lands of Harriet J. Hunter Dr. Crayton Jesse C. Hillgo and others for an accurate description of the boundaries of said land see Plat made by James H. Dickson bearing date the 27th day of May 1877 and attached to the deed of S. J. South to me the said Mary H. Stokes. The aforesaid tract of land is conveyed herein to my said daughter Henrietta E. Gaines for and during her natural life only on the following expressed conditions viz: that said tract of land shall be held used and exclusively employed by my said daughter for the annual or yearly support of herself and her children jointly during the natural life of my said daughter the rents issues Profits and income to be paid to her in dividually and personally and to no one else every year and on her own personal receipt for the same the said tract of land shall not be sold or alienated in any manner or form whatsoever by my said daughter or any other person during her natural life nor be liable for her debts or the debts of herself and children or any of them if the said land should be sold alienated or disposed off in the life time of my said daughter or if any attempt should be made by process of law to subject said tract of land or the rents issues Profits or income of the same to the Payment of the debts of my said daughter and her children or those of either or any of them then in either event as alternative said tract of land shall revert to my estate and become a Part and Parcel of my estate I give and convey said tract of land on the death of my said daughter to such of her Children as may survive her or living at her death share and share alike and should any Child of my said daughter die in the life time of my said daughter leaving a Child or Children living at the death of my said daughter such Child or Children shall take the share in said tracts of land which his or her deceased Parent would be entitled to if such deceased Parent had survived my said daughter I hereby reserve unto myself the use and enjoyment of the rents issues and Profits of said tracts of land and the absolute control and management of them during my natural life.
