 This is a contract made and entered into on this the 23rd day of July 1890 for the rent or lease of the two brick store rooms, Nos 107 and 111 Washington Street Greenville S.C. by W. A. Moore, Lessor to Alexander Prothro, Lessee.

The terms and conditions of this contract are as follows: W. A. Moore agrees to rent or lease the said two store rooms on the ground floor only, with the rear entrance chute from Lawrence Street, to Alexander Prothro, for occupancy and use by them and Merchants and dealers, for a term of three years from and including August 1st 1890, at the rent price of twenty five dollars per month, payable at the expiration of each month. Alexander Prothro agrees to rent or lease the said two store rooms from the Lessor for the term and at the rent rate above named; to pay the said rent monthly on the last day of each month; to pay all expenses for any repairs during the term of this lease and to make no alterations or changes in the place and premises

of said store rooms, and at their own expenses, as shall be agreed to by the Lessor. It is further agreed by and between the parties to this contract that Alexander Prothro & Co. shall have the right and privilege to extend the term of this lease two years from August 1st 1893, at the rent rate or price of thirty dollars per month, provided they give the Lessor notice in writing, at least sixty days previous to that date of their desire and intention to continue to occupy and use said store rooms for the additional term of two years as above stated at the increased rent price at one named, and such notice so given shall bind both the Lessor and the Lessee to a continuance of this contract until the first day of August 1895. Provided, that in no case shall the Lessee have the right to sub-rent said property to any person or persons for light or selling or meat market purposes. And it is agreed further that any disarrangement or change in the stairway or other fixtures of the said store rooms which may be caused to by the Lessor for the convenience of the Lessee, shall, at the expiration of this lease, or Extension thereof shall be replaced by the said Lessee at their own expenses.
