This indenture made this 12th day of September
A.D. 1891 between Julius H Heyward of the first
part and E B Shells and Marie J Shells of the second
part, witnesseth That the said Heyward has let and
rented to the said E B & Marie J Shells and the said
E B & Marie J Shells have hereby hired and taken
from the said Heyward all that lot of land with
the buildings thereon situated at the South West
corner of Washington and Madison Streets in the city
of Greenville State aforesaid for the term of two years
commencing on the 1st day of November A.D. 1891
and ending on the 1st day of November A.D. 1893 at
the annual rent of Three hundred dollars \$300
payable in equal monthly payments of Twenty
Five Dollars on the first day of each month

commencing on the first day of December A.D. 1891 and
the said E B and Marie J Shells her by covenant for themselves
and their heirs to pay to the said Heyward his heirs or assigns
the said rent as here before specified to keep said premises
buildings fencing &c in good repair at this expense and that
at the expiration of the said term of two years, or other determina-
tion of this lease they will quit and surrender said premises
to the said Heyward his heirs or assigns in as good condition
as when they received the same and the said Heyward hereby
covenants for himself his heirs and assigns that he said
