Whereas I Elias Earle of Alachua County in the State of Florida did on the third day of October 1873 execute unto Richard H Earle of the County of Greenville in the State of South Carolina a certain bond wherein I did agree to pay unto the said R H Earle a deed of conveyance with a clause of general warranty conveying unto him that tract or piece of land hereinafter described upon his paying unto me certain sum of money in said bond provided And whereas the said R H Earle did thereupon under and by virtue of said bond gain possession of the said premises and has remained at through himself or through his assign in possession thereof since the said date And whereas the said R H Earle has long since paid unto me the sum of money herefor referred to as provided in said bond but having neglected to make title unto him as it was agreed I should. Now Therefore know all men by these presents that I the said Elias Earle for and in consideration of the premises and in the further consideration of the sum of Four Hundred Dollars the purchase money of said premises as agreed above and which has heretofore been paid unto me in hand by the said R H Earle before the sealing and delivery of these presents (the receipt whereof is hereby acknowledged) have granted bargained sold and released and by these presents do bargain sell and release unto the said R H Earle *all that tract or parcel of land lying situate and being in Greenville County State of South Carolina lying upon the Augusta Road one and one half miles from the City of Greenville containing Thirtiem acres more or less bounded by lands of Estate of Jas Brainerd R Earle and the Augusta road - together with all land singular in the said tract or parcels bounded*
