Know all Men by these Presents, That I J H Charles of Greenville County and in the State aforesaid, in consideration of the sum of Thirty two hundred and fifty Dollars, to me in hand paid at and before the sealing of these Presents, by S G Bagwell (the receipt whereof is hereby acknowledged,) have granted, bargained, sold and released, and by these Presents, DO GRANT, bargain, sell and release unto the said S G Bagwell all that certain piece of land situated lying and being in the county and State aforesaid about two miles from the city of Greenville S.C. on the Augusta road, Beginning at a Red Oak stump and running thence S 26 1/2 W 13 1/2 rods to a rock whence S 14 1/2 W 12 1/2 rods to a stake in thence N 20 1/2 E 20 rods to a stake in in said Augusta road thence thence along said road 3 1/2 rods to a stake and thence along said road 11 1/2 rods to the beginning corner being two several parcels of land heretofore conveyed to J H Houston by J G Donaldson and Henrietta M McPhee respectively conveyed thence from J H Houston to Mrs Sallie G Earle and thence from Mrs Sallie G Earle to J S Lee and thence from J S Lee to myself Containing Thirty one and four fifths acres more or less and bounded by lands of Estates of W A McGaugh and Jas Birnie deceased and lands of Alex McNeel and others.
