in the State aforesaid for and in consideration of the sum of twenty five Dollars, to me in hand paid at and before the sealing of these Presents by Emma J Howell in the State of South Carolina (the receipt whereof is hereby acknowledged) have granted, bargained, sold and released, and by these Presents, DO GRANT, bargain, sell and release unto the said Emma J Howell all my right title and

interest in and to all that piece parcel or tract of land situate lying and being in Greenville County State of South Carolina near Rutledge Road about one mile and a half from the Court house in the City of Greenville and containing four acres two rods and twelve poles more or less and having such metes and bounds as are shown by a plat of the same made by W D Shield field surveyor by request of Albert Williams on the second day of February A D 1875 and as also shown by a plat made by the said W D Shield field surveyor at the request of Cole E Jones on the same day dated Feb 2 1875 and known and designated in both or either of said plats as Lot No 2 bounded on the north by lands of Mrs H B Anist and on the East by lands of Mrs Dr C B Stone on the south by Lot No 3 of said tract of land formerly owned by Luken Brown and on the west by Lot No 1 of said tract formerly owned by Cornelia A and W C Preston Thompson

TOGETHER with all and singular the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging or in anywise incident or appertaining.
