(1) That certain lot, lying, on south side of Earle St. in
the City and County of Greenville, State aforesaid, having
following metes and bounds; Beginning at a stake on
Earle St. corner of lot M, of Map 3, and fifty feet from
S. E. corner of Earle & Powers St., running thence with Earle
Street S 84 $\frac{1}{4}$ E, fifty ft. to stake on Earle St. corner of lot M, thence
with lot R S 5 $\frac{1}{4}$ W, one hundred & fifty ft. to line of lot N,
thence with line of lot N, N 84 $\frac{1}{4}$ W, fifty ft. to stake at corner
lot M, thence with line lot M, one hundred & fifty ft. to

and one third ft. to corner lot D, thence with line lot
D, N 5 $\frac{1}{4}$ E, One Hundred and Forty-five $\frac{1}{3}$ ft. to lot E, thence
with line of lot E, S 84 $\frac{1}{4}$ E, Fifty-four and one third ft.
to corner lot B, thence with line lot B, one hundred
and forty-five and one third ft. to beginning corner,
Being lot C, of map 5, of lands of Mountain City
Land and Improvement Company, according
to above survey.

(3) That lot on north side of Stone Avenue in said City,
County and State, having following metes and bounds;
Beginning on Stone Avenue at corner lot G, of Map
5, of lands of said Company, thence with line of Stone
Avenue N 84 $\frac{1}{4}$ W, Fifty-four and one third feet to stake
at corner lot I, thence with line of lot I, N 5 $\frac{1}{4}$ E, one
Hundred and forty-five and two thirds feet to line of
lot J, thence with line of lot J, S 84 $\frac{1}{4}$ E, Fifty-four $\frac{1}{3}$ ft.
to corner lot G, thence to the beginning corner, Being
lot H, of Map 5, of lands of said Company, according
to survey of Southern, recorded as above.
