on or about the 14<sup>th</sup> day of September in the year of our Lord eighteen hundred and Ninety two exhibited this complaint in the Court of Common Pleas, for the County aforesaid, against

demanding judgment in relation to the real estate hereinafter mentioned and described; and the cause being at issue, came on to be heard on the 20<sup>th</sup> day of November 1892, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be sold by D. P. Verner Master, in and for the County aforesaid, on the terms and for the purposes mentioned in the said decree as by reference thereto on file in said Court, will appear; and the said Master, after having duly advertised the said real estate for sale by public outcry, on the 2<sup>nd</sup> day of January in the year of Lord, eighteen hundred and Ninety three did then openly and publicly, and according to the custom of auction, sell and dispose of the same unto

for the sum of five hundred and Twenty five Dollars, being at that price the highest bidder therefor, NOW THEREFORE, Know all Men by these Presents, that I, D. P. Verner Master in and for the County of Greenville aforesaid, in consideration of the sum, Five hundred and twenty five Dollars to me paid by the said

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold, and released, and by these presents DO GRANT, bargain, sell, and release unto the said

J. P. Beam all that tract of land situate near the town of Piedmont in the County and State aforesaid on the west side of the road from Greenville to Piedmont known in the division and sale of the real estate of Reuben Beam deceased as tract No. 7 containing thirty one and five tenths acres, more or less, having the following meter and bounds, Beginning at a stake on the said road thence along the same in the direction of Greenville 14.45 to a stake, thence N 60° W 11.00 to a stake on Hannon's line, thence S 51° W to a stake thence S 77° W 17.50 to a stake on Saluda river, thence down the river to a stake, thence N 80° E 18.50 to the beginning.
