the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold, and released, and by these presents DO  
GRANT bargain, sell, and release unto the said

*J. L. Perkins* All that tract of land situate in the  
County and State aforesaid near the town of Pickens  
more or less the east side of the road leading from Greenville  
to Pickens, known in the division of the real estate of  
Archie Beam deceased as tract No. 8 containing five and  
two tenths acres more or less, and having the following  
lines and bounds beginning at a plat on said road  
and running thence N 82 1/2 E 860 to the C. & G. R. Rd thence  
along the R. Rd 1/4 40 to a stake thence N 81 1/2 W 173 to a stake  
out the road; thence along the road 9.50 to the beginning.
