D. P. Vines, Master in and for the County of Greenville aforesaid, in consideration
of the sum of *one hundred and thirty five* Dollars to me paid by the said

the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold, and released, and by these presents DO
GRANT, bargain, sell, and release unto the said

R. C. Foster

all that *piece*, parcel or tract of land situate, lying and being in the State
and County above mentioned on *Frauch's Creek*, water of *North Saluda River*, beginning on a *run*,
thence near *R. Tully's mill*, thence with *R. Tully's line* to the branch above the *Mill Pond*, thence up said
branch to a *Cherry* stump corner on the branch, thence to a white oak on *John Kieck's line*, thence
with said line to *John Shelton's line*, thence with said line to the road leading from *Mrs. Mendenhall*
to *R. Tully's mill*, thence with said road to a white oak in the edge of the *old field* above the mill,
thence to a *limestone* on the base of the *Spring branch* as the road leading from *Thomas*
Onch's to *Tully's mill*, thence with said road to the beginning, and containing *thirty five*
acres, more or less, and joining lands of *Talley Farming, Mrs. Kieck, James Daffie*
and *Mrs. Wood*.
