the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold, and released, and by these presents DO GRANT, bargain, sell, and release unto the said

all that tract or parcel of land situate and being in the State and County aforesaid, a spring land of Henny Evans, Mrs. Hamilton Rattie and James Jones, about four miles north of Marietta, and bounded as follows: Beginning on a Rock, found on the N. 70. W. 11.10 to a stone; thence N. 17 W. 4 to a stone; thence N. 75 W. 11.12 to a stone; thence N. 32 E. 18 to a stone; thence S. 47 1/2 E. 33 to a stone; thence S. 51 W. 19.50 to a stone; thence N. 88 W. 7.67 to the beginning, containing sixty-six and one half acres, more or less, being part of the land conveyed to Henny Evans by Alfred Kester by deed bearing date the 27th of March, 1857, and recorded in Book X, page 584, Register's office, Greenville County.
