(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said J. B. McDaniel all our right title and interest in and to, all those four certain, piece, parcel and tracts of land containing in the aggregate about one hundred and two acres, more or less, situate, lying & being, partly within & partly without the strictly east limits of the City of Greenville in the County & State aforesaid, & described as follows: First tract containing twenty five and a half acres more or less, beginning at a stake 30 yds. at the intersection of McDaniel Ave. & Augusta road & running thence with west side of said Ave. to a stone 30 yds. P.R. Donaldson's corner thence westwardly with Donaldson's boundary line to stone 30 yds. on the North side of St. in front of Donaldson's residence thence along north side of said St. to a stone 30 yds. on McDaniel Ave. thence along the west side of said Ave. nearly north to a stone 30 yds. Arcut Ridge St. thence along said St. on such side to stone 30 yds. Jones Avenue thence due south along the east side of said Ave. to a stone 30 yds. on Augusta road thence along North side of said road to the beginning corner, the same being known a spot of the Colman place.
